

**2010 VOLUNTEER INCOME TAX ASSISTANCE PROGRAM (VITA)
And
EARNED INCOME CREDIT (EIC)**

The VITA program gives low to moderate income residents an opportunity to receive free tax information and assistance in electronic filing of their federal and Indiana tax returns. Additionally, VITA will assist residents who are eligible to receive tax refunds from the Earned Income Credit (EIC). The EIC can be worth up to \$5,657 for families who worked in 2009 and that qualify!

Anyone wishing to use these services should be certain to bring the following required information:

- Valid picture identification for taxpayer and spouse.
- Social Security cards and birthdates for self, spouse, and dependents.
- All W-2's, W-2G's and 1099's related to income received during the year.
- If filing jointly, both spouses must be present to sign the required forms.

Additional information that may be required:

- If claiming child and dependent care expenses, the name, address, and social security number or EIN (employer's identification number) of the provider.
- If claiming the Indiana Renter's Deduction, the name, address, phone number of the landlord.
- Any tax books received.
- A copy of last year's tax return.
- For direct deposit of your refund, you must provide bank account and routing numbers.
- All 1098's related to interest on student loans.
- Out of pocket educational expenses for college
- Any donations to Indiana colleges.

Por favor traiga la información requerida:

- Identificación con foto válida para el/la pagador/a de impuestos y su cónyuge.
- Tarjetas de Seguro Social (o su ITIN *Numero de Identificación Personal del Contribuyente*) y fechas de nacimiento para el/la pagador/a de impuestos, su cónyuge y dependientes.
- Toda forma de impuesto W-2, W-2G y 1099 relacionada a los ingresos recibidos durante el año.
- Si presentará una declaración conjunta, ambos cónyuges deben estar presentes para firmar las formas requeridas.

Información adicional que puede ser requerida:

- Si reclamará gastos por el cuidado de un hijo y dependiente, el nombre, la dirección y el número de seguro social o EIN (número de identificación de empleador) del proveedor.
- Si reclamará el Indiana Renter's Deduction, el nombre, la dirección y el número telefónico del propietario.
- Cualquier folleto de impuestos que haya recibido
- Una copia de su declaración del año anterior
- Para el depósito directo de su reembolso, debe proveer números de cuenta de banco y números de ruta bancaria.
- Toda forma 1098 relacionada al interés en los préstamos estudiantiles
- Gastos educativos para la universidad de su propio bolsillo
- Cualquier donación a una universidad de Indiana
